## Minutes: July 20, 2021 Special Districts Association Meeting

The Special Districts Association of Monterey County (SDAMC) met in-person on July 20, 2021 at the Bayonet and Black Horse Golf Course Clubhouse in Seaside.

Mike Urquides and Dave Sargenti, Fire Chief and Deputy Fire Chief of Monterey County Regional Fire District, made a presentation on wildfires and the impact on fire insurance. Insurance companies are requesting the State allow a 100% increase in premiums to break even in high severity zones. If the State does not approve the increases, insurance companies will drop coverage. Insurance options for property owners include diversifying insurance coverage, maintaining legacy coverage, high premium or high deductible plans, and the California Fair Plan, the insurer of last resort. Fire Districts can reach out to insurance companies and describe local mitigation measures like fuel reduction efforts, building clearance requirements and fire-resistant building materials. Zip codes are used to identify bad areas. The Chiefs also described the Firewise program, which is a voluntary program sponsored by the National Fire Protection Association for rural areas that concentrates on fuel reduction and may help neighborhoods, as small as 8 homes, qualify for block grant fire protection funding.

Vince Ferrante reported the California Special Districts Association (CSDA) annual conference will be in person in Monterey August 30<sup>th</sup> through September 2<sup>nd</sup>. Charlotte Holifield, CSDA Public Affairs Field Coordinator for the coastal zone, reported \$100 Million was included in the State budget for Special Districts COVID relief. Districts that received direct funding relief previously will not be eligible.

Kate McKenna reported the Monterey County Local Agency Formation Commission (LAFCO) is requiring an independent financial review of the application from Monterey Peninsula Water Management District to activate a latent power to deliver potable water. The work should be completed by September and a LAFCO public hearing should be scheduled in October or December. One issue is the property tax collected by local jurisdictions from California American Water would not be paid by a public agency. The City of Soledad and Gonzalez are in the process of applying for a substantial boundary expansion.

The next SDAMC meeting is scheduled for October 19, 2021 at 6:00 pm at the Bayonet and Black Horse Golf Course Clubhouse in Seaside.
